



# FOOD DRIVE



Congratulations to all AquaWolves who swam in the Metro Championships this month. They finished fourth with 201 points which is the Wolves highest finish ever in this meet. Senior Team Captain Colin Babcock led the team with two Metro wins in the 200 yard individual medley [1:56.42] and the 100 yard breaststroke in a team record and Consideration All-American qualifying time of 59.18. Our 200 freestyle relay of Babcock, Patrick deSilva, Gavin Breaux and Christian White placed second with a team record 1:33.91, and our 400 free relay of Babcock, Breaux, White and Daniel Spell placed third. Both relays make the All-Metro team.




